# Call for participation

We are pleased to invite submissions of papers for the 8<sup>th</sup> International Conference "Regional Economic Cooperation and Harmonization of Legislation, as the premise for European Integration of Western Balkans Countries" that will be held at the Faculty of Economy, University of Elbasan "Aleksandër Xhuvani", on 21 December 2019.
